The regular promotion of Officers already officiating to the post of Asst. Director/Mgr.Gr.I on adhoc basis will take effect from 17.12.2009. However, the regular promotion in respect of officers presently working in the grade of I.I./Mgr.Gr.II will take effect from the date they will assume the charge to the promoted post at their respective place of posting. The Controlling Authorities will ensure that the procedure regarding vigilance clearance with reference to para 17.9 of the DOPT OM No.22011/5/91 Estt(D) dated 27.03.97 is followed before the relief of such officials from the cadre of Insurance Inspectors/Manager Grade-II/Superintendents.

The pay on promotion will be fixed in PB-2(Rs.9300-34800) with Grade Pay Rs.4800/- as per the provisions of FR 22(I)(a)(1). The officers concerned shall exercise their option for fixation within one month from the date of issue of this order.

All the promotees will be on probation for a period of two years from the date of their regular promotion in terms of Regulation 5 of the ESIC (Staff and Conditions of Service) Regulations, 1959.
