ii.	Attested copies of certificates and testimonials in support of proof of age/date of birth , educational qualifications, experience, registration etc.
iii.	Attested copy of community / status certificate in prescribed form in case of candidates belonging to SC/ST/OBC category. Candidates claiming reservation on the grounds of belonging to OBC category should submit the community certificate in Annexure-A prescribed vide Govt. of India, Deptt. Of Personnel & Training O.M. No. 36012/2/93/Estt.(SCT) dated 15-11-93 failing which the benefit of reservation will not be given.
