The firm(s) which intend to obtain tender documents by post will have to send the request alongwith Demand Draft of Rs.2500/- through registered post to the Dy. Medical Commissioner (Rate Contract) so as to reach him/her on or before 07.09.2011 till 11.00 AM. The Corporation will not be responsible for any delay or loss of the tender form in transit or otherwise.
